Preschool screening is for 3 and 4 year old children (must be 3 or 4 by September 1, 2013). Families from any town in the supervisory union may attend a play-based screening or apply for their child to attend at any of our three preschool sites. Please bring a copy of your child's birth certificate and immunization record to the screening. Preschool applications will be available at screenings.

Kindergarten children must be 5 by September 1, 2013. Children may attend kindergarten in the town in which they reside. Families living in a town with school choice should call the school of their choice for more information in regards to kindergarten enrollment. Please bring a copy of your child's birth certificate and immunization record to kindergarten registration.

## "Child Find Notices"

Under federal and state laws, including Individuals with Disabilities Education Act and Section 504 of the Rehabilitation Act of 1973, the Essex Caledonia Supervisory Union, has the duty to locate, identify, and evaluate all children with disabilities residing in the above mentioned towns birth to 21, regardless of whether they are currently enrolled in public school. Homeless children temporarily residing in any of these towns, and children enrolled in home school programs and or private schools are also covered by this effort. Where a child is found to meet certain statutory criteria, the school district has a duty to provide certain educational services and/or modifications and accommodations so that the child may receive a Free and Appropriate Public Education as defined by law.
